 - ~\$40-50K short
- There are other local/regional companies that could donate, but Carol & this group doesn't have contacts with them

 - Requests for useful information: Forest Service information (hiking, mushroom picking), fishing, food/restaurant, RV dump sites, gas stations
- Idea: what about a single produced map?
 - RAIN would be happy to support possibly through funding or coordination
 - There is the River Reflections guide could that be updated?

Tourism Website Proposal - Chris LaVoie

- McKenzie Community Partnership could take lead on this
- Looking for \$20-30K in grants and other donations

- Wants to work in conjunction with the Chamber to develop a complete business list
- Website, mailing list, newsletters, blogs
 - Seems like his idea would be very business-centric
 - Would highlight businesses in each post, less general content?
- He wants to encourage spending at local businesses and not in Bend/Sisters, where he sees the economic leakage is going to
- Stephen and Chris will connect to discuss content creation / overall strategy

New Business

- Pete is contacting some locals to help re-stain the community signs
 - The McKenzie Bridge sign might be the worst is having vegetation grow up all around it
 - Judy (and other real estate agents) put their signs up near the Blue River sign
 - It needs yearly maintenance from weeds / blackberries
 - Need to identify a community organization / leader who could keep them clean
- Melissa (RAIN) is going to be trained to facilitate business "destination marketing" program
 - Once she has finished that training, could offer those classes to area businesses
- Kimberly Paul is a newer Chamber member with Summit Lending
 - Interested in being on the Chamber board in the future

McKenzie History Highway

- The Track still has several signs at their facility
- Pete has talked to the Eagle Rock Lodge about putting some of the signs there
- The other Blue River signs can stay at the Track
- Pete should connect to Jeff Dehne to figure that out
